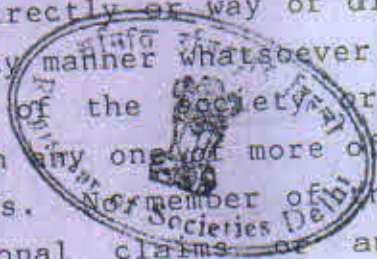
2. The Regd. Office of the Society shall be situated in the Union Territory of Delhi at present it is at H.No. 342, Than Singh Nagar, Anand Parbat, New Delhi-110005.
3. Aims and Objects:- The aims and objects for which the Society is established are as under:-
1. To open, run educational and vocational schools or institutions and to bring the education within the reach of poor and backward children in the Union Territory of Delhi.
 2. To impart free education to the poor, helpless and needy children/students, and to provide medical dispensaries in which free medical facilities would be provided to the poor persons.
 3. To provide the best education available in some of the best schools of Delhi, to produce the well informed and self assured young men and women just the kind of citizens that our so urgently needs.
 4. To provide libraries, publish books, on educational and social subjects, or to give discussions and seminars to promote knowledge and understanding amongst the people.
 5. To establish and maintain institutions for the handicapped and for adult education, like vocational training in vocations of house-hold industry, semiskilled jobs for self employment.
 6. To publish, books, charts, illustrations, Journals, magazines and periodical and other publication in different languages for the propagation of above aims and objects.
 7. To organise social, cultural festivals to create integration and unity in the society.
 8. And generally to do all acts deeds and things which are even not mentioned in this society but which may be helpful co-operative and necessary for the promotion of aims and objectives of the society.

RULES AND REGULATIONS OF
"DHARAM DEEP EDUCATIONAL & WELFARE SOCIETY"

1. Membership:

The membership of the society is open to any person or persons who has attained the age of majority and fulfils the terms and conditions of the society, without discrimination of the religion, caste, colour or creed, but subject to the approval of the governing body if the membership is refused to certain person or persons for refusal shall be communicated to the person concerned.

2. Subscription:

Admission fee Rs.10/- at the time of admission.
Subscription Rs.5/- per month.

3. Termination of membership:

The governing body shall have the power to expel a member from the society on the following terms and conditions:

- a. On his/her death.
- b. Non payment of subscription continuously for more than three months from due date.
- c. On his/her written resignation.
- d. He/she has not attended three consecutive meeting of the general body without any intimation.

4. Appeals:

All the appeals should be preferred to the General Body of the society, the decision of the general body shall be final. The reason for rejection shall be communicated to the person concerned.

5. Re-Admission:

In case of member expelled by the general body, the same can be re-admitted provided the member concerned, pays all upto date, dues. The decision of the general body shall be final.

6. Governing Body:

The governing body shall consist of all members and office bearers as under:

5. Treasurer..One. ✓
6. Members from 2.....to 16. ✓

- e. To publish literature, to propogate the system and to approach the public of the uplift the status of the society.
- f. To accept donations, charities, loans, grants, properties, etc. from public other association agencies. Govt., Deptt. in the interest of the promotion of aims and objects of the society.

13. Management of Funds:

All the income of the society shall be deposited in the ~~Bank~~ *Nationalised Bank*

functionary

14. Powers and Duties of The Office Bearers:

President:

He will be the head of the society and preside over the meeting of the general body and governing body. He will have the right of casting of vote in case of tie.

Vice-President:

In the absence of the President the Vice-President shall enjoy all powers and duties which are entrusted to the president. he will also help to the President in his work.

General Secretary:

- A. To sign on behalf of the society, conducts its correspondence and to records the pracedings of such meeting.
- B. To summon and attend the meeting of the General Body.
- C. To call ordinary general meeting if desired on written request of ~~at least~~ *at least* twenty members.

Secretary:

In the absence of the General Secretary the Secretary shall enjoy all powers & duties which are entrusted to the General Secretary. He will also assist to the General Secretary in his work.

Treasure:

He shall keep accounts of all receipt and expenditure of the society and to furnish necessary information of the governing body. He will keep with him Rs.500/- and the balance amount will have to be deposited in the Bank/post office etc.

15. Audit:

The account of the society shall be audited atleast once in a year by an auditor appointed by the Governing Body.

7. Bank Accounts:

The Bank Account of the society shall be operated by the Treasurer and any one out of the general Secretary and President.

8. General Body:

All the members of the society will constitute the general body.

8.A. Functions of the General Body:

- A. To consider any business brought forwards by the governing body.
- B. There shall be an annual meeting of the general body in the month of March every Year.
- C. Not less than 15 days notice shall be given to the members before the date of general body meeting enclosing the agenda specifying date time and place.

9. Sources of Income:

- i. Admission Fee.
- ii. Subscription.
- iii. Donations and Special contribution.

10. Governing Body:

The governing body's strength shall not be less than 7 and not more than 21. The member of the governing body shall hold the office for two years. The meeting of the governing body shall hold the office and with necessary 15 days clear notice will be required.



11. Election and Quorum:

The General Body its annual meeting will elect its president and all the office bearers and members after two years, by secret ballot papers, The quorum of the General body and governing body shall be 2/3rd.

12. Functions of the Governing Body:

- a. To arrange, finance if required from other Bank(s), institution or individual on reasonable terms and conditions and governing body as a whole is liable for its return.
- b. The governing body shall make plan for the future programmes of the society.
- c. To appoint, terminate and fix duties of the stall.
- d. The governing body shall meet at least once in a month.

16. Financial Year:

The financial year of the society shall start from the 1st day of April to 31st day of March every year.

17. Tenure:

The terms of governing body shall be two years.

18. Amendment:

(Alteration, extension of abridgement), of puposes' (Aims and objects) or any change in rule Regulation shall be as Section 12 and 12-A, of S.R. Act of 1860, as applicable to the Union Territory of Delhi. The amendment in the memorandum of a shall be made under this section.

19. Legal Proceedings (Section of 6 of the Act):

The society may use or be used in the name of the president of as per provisions laid down under section 6 of S.R. Act of 1860 as applicable to the Union Territory of Delhi.

20. Annual List of Governing Body shall be filed with the registrar of society Delhi as required under section 4 of the societies regn. Act of as applicable to the Union Territory of Delhi.



21. Dissolution:

If the society need to be dissolved it shall be dissolved as per provisions laid down under section 13 & 14, S.R. Delhi of 1860 as applicable to the Union Territory of Delhi.

Application of the Act:
